#### LIST OF MICROBES THE EPA HAS DETERMINED TO BE PRESENT IN NEW ZEALAND

The microorganisms imported must be on the list of microbes present in New Zealand (found at https://www.epa.govt.nz/industry-areas/new-organisms/about-new-organisms/) and not unwanted organisms.

In addition to this import permit, a declaration is required to accompany each consignment. The declaration must, for each species,:

- Confirm the species being imported (full scientific name genus and species);
- Confirm the species is on the EPA's 'List of microbes the EPA has determined to be present'
- Confirm the species is not a genetically modified organism (as determined by the Environmental Protection Authority (EPA) under the Hazardous Substances and New Organisms (HSNO) Act; https://www.epa.govt.nz/database-search/hsno-application-register); and
- Confirm the species is not an unwanted organism (as per the Official New Zealand Pest Register;

The declaration must additionally:

- Include product descriptors that match with official or commercial shipping and/or invoice documents;
- Be prepared by the manufacturer or the supplier on letterhead of the appropriate organisation; and
- Be signed and dated by the quality manager of the manufacturer or equivalent

NOTE: Identification down to genus level only is NOT acceptable.

NOTE: If a species is listed as present in New Zealand, any subspecies are also considered by the EPA to be present in New Zealand.

NOTE: There may be other legislative requirements that need to be met before any use in/on animals can occur (includes both direct use and products manufactured from the imported microorganisms).

### IFM QUALITY SERVICES PROFICIENCY PANELS

It is the responsibility of the importer to ensure IFM Quality Services has provided the MPI Animals Approvals and Advice team (animal.imports@mpi.govt.nz) with a list of viable microorganisms in the consignment BEFORE the consignment is dispatched. This is to provide assurance all microorganisms being imported within these panels meet the requirements of clause 6.2 of MICROIC.ALL.
